### Remarks

1. The monthly fees cover tuition and supervision from 7.30 a.m. to 4.30 p.m. For students in primary school and secondary school **attendance** from 8.30 a.m. to 4.30 p.m. Monday through Thursday, and from 8.30 a.m. to 1.45 p.m. (grades 1 to 4) respectively 3.15 p.m. (grades 5 to 13) on Friday is **mandatory**.
2. Families who enroll two or more children in grades 1 to 13 at SIS Berlin and who pay the regular tuition fees according to the price list shown above, receive a **sibling discount** in tuition fees of 20%. The reduction is applicable to the fees for the second child and any additional children. The fees for the oldest child are to be paid in full. The one-time entrance fee as well as expenses incurred for any additional services are not affected by this reduction. A special sibling discount applies to income-based school fees, please see below for further details.
3. **After School Care** between 4.30 p.m. and 5.30 p.m. is an additional offer and shall be covered by a separate arrangement. You can take advantage of this offer for one or more (up to five) weekdays. Please note that the booking of specific weekdays within the After School Care cannot be changed for at least one school semester (Sep 1 - Feb 28/29 and March 1 - Aug 31). Additional days can be booked during the course of the year. This has to be coordinated and approved by the principal and depends on available resources.
4. SIS offers also **income-based school fees** in grades 1 to 13. Fees are based on the annual (worldwide) gross family income of the previous calendar year (2023). Interested parents need to fill out an evaluation form of family income and send it back to SIS, together with the applicable supporting documents. Family income includes, amongst others, salaried or self-employed income, income from rent or investments, child benefit, alimony and tax-free earnings. Negative income cannot be deducted from positive income. All supporting documents have to be in German or English. Costs for a possible translation must be covered by the family. These documents need to be provided on a yearly basis. If the evaluation form of family income and / or the supporting documents are not provided on the given due dates, SIS will charge the regular tuition rate. Please contact the school management who will inform you about further details and deadlines.

5. You have the option of purchasing **lunch** from an external provider. Please contact the school office for further information.
6. The **SIS Shuttle Bus** transports our students from the Haus des Rundfunks/ICC-Messegelände to school in the mornings and brings them back in the afternoons. There is a limited number of seats available on the bus. Please contact the school office for details.
7. All fees are monthly average rates based on calculations for 12 months per year (respectively 6 months per semester). This means payments are due **12 months per year**, including the holidays. Payment of fees needs to be made one semester in advance. Parents who prefer to pay on a monthly basis will be charged a surcharge of 3% on each payment. Parents who make an advanced payment covering the whole school year will be offered a 2% discount. SIS will ask parents about their preferred mode of payment; any subsequent change involves an administration fee, which is 50 € for each invoice (resp. for each invoice line item within collective invoices) to be changed.
8. The **one-time entrance fee** is due upon signing the school contract and is non-refundable.
9. **Costs** arising from non-obligatory offers or activities, such as **transport, lunch, class trips, excursions** etc. as well as the **assessment fees for the IB Diploma** in grade 13, are **not** covered by the school fees. The assessment fees will be invoiced separately to the parents including an administration fee of 50%.
10. SIS follows the official **Berlin school calendar**.
11. Please note that contents referring to booking and terms of payment are provisional. Detailed and legally binding modalities will be outlined in the school contract and, if applicable, additional agreements. The listed fees are valid for the school year 2024/25. The SIS reserves the right to adjust its fees.
